**Town and Country Planning Act**  
**Appeal by Mr Larry Edmunds**  
**Site at Stowey Quarry, Stowey Road, Stowey**

I act for Bristol Water Plc (BWP) in relation to this matter. I have received a copy of your letter dated 14 August 2013 together with the Inspector's note.

This is an unusual situation but I will try to assist by clarifying the water company's position. BWP have provided evidence to BANES as LPA in objection to these proposals. BWP intended to appear as a witness for BANES in resisting this appeal. If the Inspector determines that the proposals cannot be modified as requested by the Appellant I understand that BANES will maintain its resistance to the appeal. In that event BWP will continue to assist BANES and to appear as part of the LPAs case.

If the Inspector decides to accept the amended proposals and BANES decide to withdraw their objection BWP would still wish to maintain an objection in its own right. The extent of that objection is intended to amount to presenting the evidence already lodged by BWP. BWP also have some concerns about the conditions that are presently being discussed in the event of permission being granted and therefore may need to make representation in that respect. To assist with that are you able to forward to me a copy of the draft conditions as sent to the Inspector?

I intend to attend the inquiry on Tuesday primarily to advise BWP on what is happening and if necessary to explain further BWPs position. I do not intend to request "rule 6" status at this late stage and therefore am not intending to cross examine other party's witnesses etc. I will obviously assist the Inspector in any other way that I am able.


